

A word about the abortion stories included in this guide...

Throughout Pathways to Life you'll find personal accounts written by pregnant mothers who underwent abortions. We found most of these narratives at ShoutYourAbortion.com.

Launched in 2015, Shout Your Abortion is self-described as a "movement working to normalize abortion through art, media, and community events all over the country." Its website invites pro-abortion, post-abortive mothers to relate their abortion experiences.

SYA's goal is to paint abortion as a normal activity and heralded constitutional right, like voting or free speech.

The problem is abortion is neither and never will be.

Ironically, the very forum intended to show abortion pride instead unmasks its depravity. The stories are heart breaking, and a few are horrific. They show that most times abortion is an unwanted last resort, compelled by tragic circumstances.

We share some of these stories throughout this guide, without commentary, because pro-life commentary isn't needed to point out the pain described by abortion advocates themselves about their own experiences.

Welcoming Life in Mississippi

While the abortion rate in Mississippi is only a third of the national rate for the United States, abortion totals in the state have been increasing since 2013. The state has just one free-standing abortion facility, which is in the national spotlight due to the landmark case now before the U.S. Supreme Court, Dobbs v. Jackson Women's Health Organization.

What is driving the increase in abortion in The Magnolia State? Statistically, the answer is clearly the expansion of chemical abortion, which began to rise there in 2012. Abortions by chemical means now constitute 71 percent of abortions in the state. Moreover, the state maintains a stark racial gap in abortions – black women in the state were subject to 74 percent of the abortions in 2019, occurring at a rate four times higher than for white women in Mississippi.

Key indicators compiled by the Charlotte Lozier Institute show a range of challenges reflected in several culturally conservative states. For example, Mississippi ranked 50th in 2019 in median household income.

 Roughly one in five Mississippians (19.6%) live under the poverty line. Medicaid eligibility in the state is capped at 194% of the poverty line.


- As of December 2021, 21 percent of Mississippi residents were receiving Medicaid. The national percentage is 22.90. Mississippi is one of 12 states without Medicaid expansion currently.
- Nineteen percent of the 584,300 women of childbearing age (15-44) in the state are uninsured.
- The state's infant mortality rate is the highest in the nation. Its preterm birth rate, teen birth rate, cesarean section birth rate, and rate of low birthweight are all significantly above the national average.
- Fifty-five percent of all births in Mississippi are out of wedlock, well above the national percentage of 39.6% and second only to New Mexico.


TOTAL ABORTIONS BY RACE / AGE MS RESIDENTS AND NONRESIDENTS 2019

2019 MISSISSIPPI TOTALS ABORTIONS BY AGE




TOTAL ABORTIONS / ABORTION RATE MS RESIDENTS PLUS NONRESIDENTS

MISSISSIPPI TOTAL ABORTIONS 2005-2019




MISSISSIPPI TOTAL ABORTION RATE* 2005-2019

*NUMBER OF ABORTIONS PER 1,000 WOMEN OF CHILD-BEARING AGE



In Mississippi, state law requires that mifepristone be dispensed in person by a licensed physician after a medical exam to rule out pre-existing conditions; mifepristone may not be distributed through the mail.

However, some abortion groups, including Aid Access, are openly advocating to flout any restrictions in law and illegally mail abortions pills to women across America.

As a result of the pandemic, the Food and Drug Administration acquiesced to a request from the abortion industry

and temporarily allowed mifepristone to be dispensed through the mail.

In December 2021, the FDA announced it was making that change official and also allowing pharmacies to become certified providers of chemical abortion.


Consequently, chemical abortion by mail is now legal in states without their own laws requiring that it be dispensed in person.

TOTAL MISSISSIPPI ABORTIONS 1973-2019



SOCIAL, HEALTH, AND FERTILITY MEASURES 2019













Conclusion

Key Services and Trends

Pregnancy help centers (PHCs) continue to offer a growing array of support and services to women as an alternative to abortion and a path forward in Mississippi.


PHCs outnumber abortion facilities by 34 to one. The centers employed over 100 licensed medical providers in 2019 and delivered 4,519 free pregnancy confirmation ultrasounds, 7,674 free pregnancy tests, and 393 sexually transmitted infection tests. Overall, the value of the services provided to 12,351 Mississippians in centers across the state was nearly \$1.9 million in 2019. Providing more help to the just over 3,000 women in Mississippi who choose abortions annually in the state is within reach. Mississippi has more than \$1 billion in unallocated and "rainy day" funds in state coffers.

Adoption


Information from adoption.com notes that private adoptions in the state can cost between \$10,000 and \$40,000, including legal and agency fees and possibly medical charges. The state supplements the federal tax credit with a state income tax credit up to \$2,500. The state also subsidizes foster care and provides a foster care charitable credit. Adop-

tions arranged through the state's foster care system can be accomplished at little or no cost.

In 2017, the Mississippi Department of Child Protection Services (MDCPS) launched an aggressive effort to resolve adoption cases that have lingered in its foster care system. The result has been a doubling of adoption totals from the system, with the latest available numbers from state fiscal year 2019 showing 657 adoptions. With more than 3,500 children and teens in foster care, there is room for further increases. Mississippi has developed what it calls a "Heart Gallery," featuring capsule biographies of 47 children and teens who are legally free for adoption. These initiatives have helped reduce the foster care rolls in Mississippi by 20 percent since 2015.

Safe Haven Law

Safe Haven laws, sometimes called "Baby Moses" laws, have been enacted in all 50 states and the District of Columbia. They allow a parent, under limited conditions, to anonymously relinquish a baby up to a certain number of days after birth, with no questions asked and no culpability under state child abandonment and criminal laws if the baby is unharmed.

This legal reform began in Texas in 1999, and Mississippi swiftly adopted it. To date some 4,400 children have been relinquished this way nationwide.



Mississippi's law allows women to relinquish a child up to three days after birth into the custody of a hospital, fire station/EMS provider, or a licensed adoption agency. Mississippi's three-day limit on relinquishment is similar to the law of eight other states and Puerto Rico. The vast majority of states allow relinquishment within seven days, with some ranging as long as 30 days or age or up to one year. The scarcity of infants available for adoption, relative to the number of couples seeking infants, is striking.

On an annual basis, Mississippi has roughly 100 abortions for every completed infant adoption.

Services for Mothers

Rural health care in the United States is plagued with challenges for staffing, facilities, and finances. A 2020 report from the March of Dimes updated findings about U.S. counties it called "maternity care deserts," places where there is neither a hospital providing maternity care and delivery services nor even a single OB-GYN.

Some of the counties are sparsely populated, but others are experiencing a shortage in facilities and providers. Overall, the report says, there are 1,095 such counties in the U.S., and 150,000 babies were born in these counties in 2017.

Mississippi ranks among the five states with the highest percentage of uninsured women of childbearing age at 19 percent. It is also among the lowest five states to avail themselves of the alternative of certified nurse midwives to improve care and lower costs for low-risk mothers on Medicaid.

Partner with assistance providers to serve pregnant and parenting moms in need

How collaborating will serve your church

Pastoral confidence: Through relationships with Her PLAN assistance providers, you and your leaders can refer pregnant congregants with confidence to experts who will provide ethical guidance.

Resources: Your pregnant congregants in need will have access to maternity and baby clothes, baby furniture, diapers, cribs, car seats, strollers, and more.

Life skills: Many pregnancy help centers (PHCs) offer classes on parenting, healthy relationships, money management, after-abortion healing, and more. These can help your pregnant congregants with inadequate support systems get proper training on fundamentals as well as break free from generational dysfunctions.

Services to your church: PHCs have materials and trained staff to teach risk avoidance/healthy relationships/abstinence classes to your youth group, train your congregants and leaders how to identify victims of sex trafficking, and more.

How collaborating will serve your community

Your local PHC will rest assured knowing clients it refers to your church will receive acceptance, spiritual guidance, and help. Don't forget to invite PHC staff to church, too!

Did You Know?

According to data from The Guttmacher Institute, 54% of women who have abortions identify themselves as Christians. Our research found that four in 10 women were regularly attending church at the time of their abortion.

Well, we could, but that is certainly not what Jesus did. He was in the midst of our messy situations. I encourage you to be too.




We already have a very limited budget. How can we afford to start a single moms' ministry?





Did You Know?



When I would go home at night, incidents of reaching for alcohol to numb me started to increase. In the drowning-out process, I would tell myself that the pain was worth it to provide for my kids....

I found myself very drawn to the presence of a woman named Mary, one of the prayer volunteers who stood with the protesters outside of our clinic, because her demeanor was so different from the rest.

Where they were mostly hostile and boisterous, she simply prayed her rosary. I approached her and asked if I could have one. "Do you know how to pray the rosary?" Mary asked.

I told her as a former Catholic, I did. When she gave me one, it seemed to start something new in me. I went from rationalizing the reasons why I worked there to a firm conviction that I was going to leave Planned Parenthood. I began going to her for prayer before every shift.

Finally, the morning came when I arrived in front of Mary with a slightly different need. "I'm only here today to say goodbye to you. I'm going to leave after this shift, and I need you to pray for me because when I walk away from here, I'm never coming back. And I don't know what I'm going to do."

She prayed with me immediately. Scared to death about my future without a job and still in shock, I surrendered everything in my life to God....Through tears and confession, I felt changed, even new. It was and is the most groundbreaking event of my life—when God called me back to Himself.

I DO NOT KNOW HOW I FELT, BEING A CHRISTIAN: BUT I KNEW I WAS OUT OF SORTS TO CARRY A PREGNANCY.

I had my first abortion after a year from college. I asked God for forgiveness and promised Him it would never happen again.... I was wrong!

I am 33, married for 6 years with two sons.

I found out I was pregnant [again] in December. My youngest was only 5 months, and I deliver by C section. My pregnancies are quite challenging.

I just could not go through the ordeal just after 5 months. I was emotionally unstable, my marriage was just not going well, I had no help at home, I knew taking care of a toddler while pregnant would be a handful.

I do not know how I felt, being a Christian: but I knew I was out of sorts to carry a pregnancy.

I went alone, I knew my husband would never approve. I had a medical abortion about 2 months ago. I was about 5 weeks pregnant. Still recovering

from the emotions that come from terminating a pregnancy.

No one offered me much support and understanding, not even my husband. It's not a choice I made lightly this time around. I asked God to forgive me, I asked Him to understand....

I sometimes wonder if I had maybe been strong enough or got the support I needed, I would still be pregnant, I keep imagining it would have been a girl, but I also know I was just not ready.

I do not talk much about it. I pray, I know God has forgiven me, I know He is a good father who understands, knows our weakness as humans....

I pray and hope to carry one last pregnancy, when my son turns 2. Praying for a girl.



In its 1973 *Doe v. Bolton* decision, the companion case to *Roe v. Wade*, the Supreme Court defined "health of the mother" so broadly that abortions can be obtained for basically any reason.

That said, serious health issues can arise during pregnancy, as described in "Her mind at the time" on this page. These deserve to be addressed, while not condoning abortion as the solution.

It is also important to ensure pregnant mothers in need obtain good prenatal care and health care.

Then, there is the "well-being" component in this category, which eye-opening research by the Vitae Foundation (vitaefoundation.org/trauma-of-abortion/) has found to be a significant hurdle to choosing life.

Vitae learned that some pregnant mothers, especially who are young and didn't plan this, think their internal selves will die if they have a baby:

Pregnancy and motherhood completely shatter some women's ideas of who they are and who they plan to be. In their minds, motherhood is equated with a kind of death....

Whether right or wrong in the abstract, under the panic of this life-changing crisis, abortion can seem to align itself with the deep and universal instinct of self-preservation....

The pro-life tendency to focus exclusively on the child, rather than on the woman's own circumstances and emotional needs, only deepens the woman's sense of isolation and despair – the very emotions that often lead her to choose abortion.





Have you ever heard of Hyperemesis Gravidarum? It happens in 1 – 2% of pregnancies....

Dehydration, excessive vomiting (sometimes uncontrollable), constant nausea and dizziness, weight loss, malnutrition, sensitivity to light, sound, smell and touch, aversions to foods and water... the list goes on....

As I excessively vomited, unable to consume food or drink each day, I felt the weight of death on me and my unborn child. Medical interventions were failing us....

Would I stay for my born children, or would I go with my unborn?

I chose abortion. I chose life.

A pregnancy without prenatal care is a dangerous pregnancy, even if the mother has no known health conditions or pre-determined pregnancy risks. For example:

- Pregnancy complications, such as gestational diabetes, miscarriage, high blood pressure, and preeclampsia
- Worsening of chronic conditions, such as diabetes, asthma, and heart problems
- Ante- and post-partum depression and other adverse mental health issues
- Negative effects on the baby, like preterm delivery or low birth weight

Perhaps the most stunning statistic? Babies whose mothers received no prenatal care are 5x more likely to die than those whose mothers received regular prenatal care.

How collaborating will serve your community:

Awareness: A large number of our recommended health providers offer discounted or free services to women who are in poverty or uninsured. Women just need to know. Plus, many include a spritual dimension in their care.

How your church can serve and collaborate with life-affirming providers:

VOLUNTEER

Recruit: Recruit church members with a health care background to volunteer in their area of specialty at a local health provider in our network.

Pray: Consider opportunities to pray for health care providers, such as conducting a prayer walk at a facility.

Internships: Do your partnering assistance providers in this category offer internships? If not, ask them to consider doing so. Along with helping the provider, this will reinforce the value of life and life-affirming work to your high school and college students, while satisfying service hours required by many schools. Every year in this country, approximately 700 women die of complications related to pregnancy and childbirth and more than 50,000 women experience severe maternal morbidity, a life-threatening complication as a result of labor and delivery.



The first time I was 25, in New York. From the time I was a teenager, the idea of having an abortion if pregnant was a no-brainer. I had this idea you can't let life get in the way of your plans.

My friend drove me. The procedure was in a tiny, bright, white room – it was like a nightmare, but it was over really, really quickly.

They moved me into this communal healing room. Women were reclining on big, pillowy chairs. I remember feeling comforted, warm – we'd all been through the same experience.

Two years ago, I was in Oklahoma. I wasn't given a choice in method – I got the pill. My boyfriend worked in Idaho – I was alone.

They gave me all this paperwork that said, "This is serious. You could die," and an antibiotic, painkiller, and a latex glove and a pill. At home, the antibiotic made me vomit and sh** everywhere.

After my contractions started, my hands turned into claws. I was dehydrated. I had this underlying feeling that I was being made to suffer, to repent for my situation....

I got up to pee, and this gray golf-ball thing came out.

I thought, so I just flush the toilet?



How collaborating will serve your church

Pastoral confidence: Your leaders will have resources at their fingertips to help your pregnant or parenting mothers in need. An array of life-affirming assistance providers specialize in caring for this segment of the population.

Congregants will know their church community is tangibly investing in their own people in need as well as the community around them. They will also have access to the same information (online) as their leaders to aid those in their own sphere of influence.

Services to your church: Life-affirming providers in this category offer educational help (scholarship applications, GEDs, English as a second language, etc.), work training (technology, resume building, professional wardrobe, etc.), life-skills training (budgeting, debt consulting, etc.), and financial help (rent, utilities, health care, etc.).

Life-affirming providers can be asked to teach a class at your church on any of the aforementioned resources.





Details: Reducing the number of no-show appointments has been an ongoing goal for us. We discovered transportation issues were a common denominator. Since incepting our cab service program, we have seen our monthly no-show rate decrease from over 20% to between 11%-12%.

The day before the appointment I couldn't sleep.

but for him or her.

March 23rd, an angel was sent to heaven.

One that will look after my boyfriend and I.

I want to say sorry for not being able to keep you. Maybe I should've been stronger or I should've just done it without looking back.
But I had to let you go baby. It was the hardest thing I have ever done. My heart is broken. I think about it every day. It is something that will stick with me, something I will pray for all the time.

Maternal prenatal nutrition and the child's nutrition in the first 2 years of life (1,000 days) are crucial factors in a child's neurodevelopment and lifelong mental health.

Child and adult health risks, including obesity, hypertension, and diabetes, may be programmed by nutritional status during this period.

Calories are essential for growth of both fetus and child but are not sufficient for normal brain development....

Failure to provide key nutrients during this critical period of brain development may result in lifelong deficits in brain function despite subsequent nutrient repletion.



To help them to feel they are valued and loved no matter what issues they're going through."

LEGAL SUPPORT

Host a monthly legal clinic, either on-going or on a weekly or monthly basis.

Details: CLA is a ministry. Often, clients' legal problems are tied to interrelated emotional, relational, and spiritual problems. So in addition to helping with the legal issues, CLA volunteers try to minister to clients holistically by providing a compassionate listening ear, spiritual counsel, and prayer.

Often clients are equally or even more blessed by the spiritual component of CLA than the legal services. Many of them come to CLA full of anger, despondency, and bitterness. They might not have friends to turn to and may never step foot in a church, but because CLA attorneys can help them with a tangible need, they are more open to sharing their lives and pouring out their hearts. CLA attorneys are there to be a witness to the love of Christ.



Pro-Tip: Legal

We have found that women in dire straits often lack legal documents, such as birth certificates, passports, IDs, and Social Security cards for themselves and their children, and lack the skills to pull them together without guidance.

Launch a courthouse ministry

Pastor David Burgher holds church at one of the most unique places you'll ever hear: Georgia's Gwinnett County Courthouse.

Pastor David providentially meets, counsels, and prays with people and families in the courthouse halls

"The courthouse is the city gate to the whole county," explained Pastor David to us over lunch. "Everything that goes wrong in the county culminates right there."

Pastor David ticked off a list: "Child custody cases, probate, DUIs, drugs, license certificates, marriages, guns, evictions, death certificates, adoptions, divorces, and tax issues. Any major sin in the entire Bible, or major life event, goes through that building."

The legal needs of pregnant and parenting mothers in crisis include overdue child support, establishing paternity, custody battles, evictions, and restraining orders against violent partners.



I asked how Pastor David meets people.

"The most unasked and powerful question ever is: 'What is it I can pray for you now?' This is the biggest open door," he said.

"The question denotes that you care about the person. It denotes you don't have all the answers, and you're inviting the CEO of the Universe into that conversation."

He continued, "In the courthouse it's not how much you know but how much you care."

Pastor David finds people are ready to open up "big time." He's on the phone a lot, too.

"Stopping to pray right where you are is 90% of the miracle people are looking for. God starts shifting events. This is a building of judgment, so the last thing they're expecting is mercy."



The paths pregnant mothers take – or are forced to take – to land in this category of need can be horrific.

Not only is abortion violent to both baby and mother, there may also be pregnancyrelated complications.

And we're not just speaking about maternal health, although it's true adverse emotional and mental health can be both a precursor to and complication of abortion.

Exploitative traffickers, pimps, and partners rely on abortion as birth control and may not take well to a pregnant mother choosing life.

The pit of hell is bottomless, and Satan continues to dig deeper, doing his utmost to degrade and annihilate we who are... the only beings God created in His own image.



We are reminded of the quote by Randy Alcorn of Eternal Perspective Ministries:

The best of life on Earth is a glimpse of Heaven; the worst of life is a glimpse of hell.

The tragic figures in this category are not just "glimpsing" hell. They're in it. Hell on earth. Let's partner with God and pull them out.



Partner with assistance providers to serve pregnant and parenting moms in need

How collaborating will serve your church

Pastoral confidence: Leaders encountering needs in this category know the problems, while not too big for God to handle, are likely too big to handle themselves.

When ministering to a pregnant mother suffering from addiction, abuse, or a mental disorder, two lives hang in the balance. Specialized help – and sometimes specialized housing – are needed to ensure the health and safety of both mama and baby. We've done the scouting and vetting and have resources ready for you.

Life skills: If a pregnant mother is in bondage to a personal vice or other people, we want her to receive help and healing. The outcome is a healthier person to care for her healthier baby in a healthier way - and a healthier member of the body of Christ.

Services to your church: Assistance providers can lead recovery and mental health support groups for your congregants. They can also train your staff and leaders on signs to identify sex trafficking and abuse victims and women in mental distress.

How collaborating will serve your community

This is a messy category – one where affected women may feel judged by the collective Church. "Come as you are"? Many don't believe that.

Abortion is statistically linked to elevated risks of suicide attempts and completed suicide, sleep disorders, addiction or misuse of drugs and/or alcohol, bi-polar disorder, depression, anxiety, post-traumatic stress disorder, anger or rage, difficulties parenting, increased risk of premature death, and other emotional and mental health issues.

Your church can be a refuge to those struggling in these areas who would normally – rightly or wrongly – feel hesitant to seek spiritual counsel.

Yours can be known as the church of compassion and acceptance, one to which your partnered assistance providers will be comfortable sending these lost souls for love and acceptance — just as they are.

As part of the check-in process for every female a pregnancy test is required, and as it turns out, I was pregnant. I burst into tears because I knew what I had to do. In my mind it [abortion] was the only solution.... I didn't want a heroin baby, and I didn't want to destroy a child.

They gave me my first pill at the clinic. I went home to wait until I needed to take the next pill. While I waited, I talked to my stomach, to the embryo, explaining myself, telling it how sorry I was. I cried as I said I'm so sorry. I'm sorry I can't be your mother. I'm sorry I can't bring you into this world.

Eventually it was time to take the pills. About an hour later I felt the worst cramps I have ever felt. I ran to the toilet. I felt something hard exiting. It was the embryo. I felt horrible...an embryo that would have been a

baby, an embryo that could have been a boy or a girl and had a life and children of their own and because of me was sitting at the bottom of a toilet, because I was too busy getting high to really think about better contraception.

I prayed over the embryo in the toilet – prayed that they would know how sorry I was. I must have sat there for over an hour. I couldn't bring myself to flush the toilet, but I eventually did. But right before I flushed it, I made the sign of the cross over the toilet (I grew up Catholic).

I wish I could tell you I got clean that time, but I didn't. It took some more things to happen and a few more detoxes and a rehab....

The prevalence of Intimate Partner Violence

(IPV) was nearly three times greater for women seeking an abortion compared with women who were continuing their pregnancies.

A review of 74 studies confirmed IPV is even more strongly associated with repeat abortion. Findings support the concept that violence can lead to pregnancy and to subsequent termination of pregnancy, and that there may be a repetitive cycle of abuse and pregnancy.

Homicide is a leading cause of death during pregnancy. In the majority of cases, the murderer is the woman's intimate partner.




The unpardonable sin?





McNeal said investigators had chastised her for seeing a spiritual adviser instead of a psychiatrist while she was suffering from depression after the abortion.

I told them, 'Oh, really? For me, growing up in the Black community, that's how we cope with everything — we go to church and we talk to our pastor or spiritual adviser,' she said....

McNeal said that as a Christian, she felt guilt about the abortion, which she underwent so she could compete in the 2020 Games. She said she was even more crushed when the Games were postponed until 2021, because the delay meant she could have had the baby after all.

Eugenics is the selective breeding of human beings, designed to eliminate the "imperfect" from among us.

Influenced by his cousin Charles Darwin's theory of natural selection, British scientist Francis Galton first coined the term "eugenics" in 1883, for the concept of selectively breeding humans to garner higher quality stock.

In early 20th century America, eugenics was considered a legitimate pursuit – that is, until the Nazis decimated its reputation in the 1930s and 40s.

Although the term fell from grace, the concept lived on, and in 1956, when amniocentesis was first used for genetic testing, eugenics invaded the womb. Today, it is masked by the euphemism, "a woman's choice."

What a choice. From the December 2020 *Atlantic* article, "The Last Children of Down Syndrome," (u.nu/lastchildren) by Sarah Zhang:

Activists have pushed back against the subtle and not-so-subtle ways the medical system encourages women to choose abortion....

In the interviews I've conducted, and in interviews [anthropologist Stina] Lou and researchers across the U.S. have conducted, the choice of what to do after a prenatal test fell disproportionately on mothers.

For the women in Lou's study, ending a pregnancy after a prenatal diagnosis was very different from ending an unwanted pregnancy.



These were almost all wanted pregnancies, in some cases very much wanted pregnancies following long struggles with infertility. The decision to abort was not taken lightly.

For some who end up choosing abortion, "their own self-understanding is a little shaken, because they have to accept they aren't the kind of person like they thought," [Lou] said.

They were not the type of person who would choose to have a child with a disability.

One woman I'll call "L" told me how terrible it was to feel her baby inside her once she'd made the decision to terminate. In the hospital bed, she began sobbing so hard, the staff had difficulty sedating her.

The depth of her emotions surprised her, because she was so sure of her decision. The abortion was two years ago, and she doesn't think about it much anymore. But recounting it on the phone, she began crying again.

Let's help mothers "choose" the better way.

How collaborating will serve your church

Pastoral confidence: As prenatal testing expands, church leaders should anticipate the need to counsel a woman or couple who has received devastating news about their preborn baby, usually one of four life-limiting diagnoses:

- Disability
- Medical condition
- Possibly fatal or life-threatening physical condition
- Baby has died in utero

Unfortunately, in the first three cases many medical professionals (doctors, social workers, genetic counselors, etc.) pressure a woman to the hopeless decision to abort.

Therefore, it is important to plug her into a hopefilled network of assistance providers and doctors who are life-affirming during this frightening and confusing time, and who you know will offer sound guidance. This network includes perinatal hospice providers if the baby may die after birth.


Services to your church: You will be armed with resources for the family as well as objective information about common maladies.

Our providers will also help your church prepare to accommodate and welcome these children into your fold.

If there is a miscarriage or loss, your church will know how best to comfort the family – what to say and do and not say and do.



"I could not bear the thought of this suffering child dying alone in a Soiled Utility Room..."

I am now Her PLAN's Community Outreach Manager, but I have a backstory to share.

he blunt words on the report were clear.
It said we were aborting a baby with Down syndrome that evening. I was completely shocked.

I had been working for a year at Christ Hospital in Oak Lawn, Illinois, as a registered nurse in the Labor and Delivery Department, specifically choosing to work at a Christian hospital because I expected it not to be involved in abortion. It hurt to learn the very place these abortions were being committed was named after my Lord and Savior, Jesus Christ.

I was further grieved to learn the hospital's religious affiliates were pro-abortion. I had no idea any Christian denomination could take such a position.

Compounding my distress was learning the abortion method Christ Hospital used - and still uses - is called induced labor abortion.*

The goal is to artificially induce labor and delivery of an extremely premature baby with the expectation the baby will die during the birth process or soon afterward. Some abortionists kill the baby before inducing labor by injecting her heart with a medication that causes instant cardiac arrest.

It was not uncommon for a baby to survive his or her abortion. A Christ Hospital Chaplain told the *Chicago Sun-Times*, "between 10 percent and 20 percent of fetuses with genetic defects that are aborted survive for short periods outside the womb."

By my experience the percentages were higher, and survivors could linger for an hour or two or longer. One baby lived for almost an entire eight-hour shift. Further,



some babies had no "defects," as Christ Hospital also aborted for rape, incest, and "health of the mother," a phrase the Supreme Court defined so broadly as to basically allow abortion on demand throughout all nine months of pregnancy.

In the event an aborted baby survived, she received "comfort care," defined as keeping the baby warm in a blanket until she died. Parents held their dying baby if they wished. If not, a staff member cared for the baby.

If staff did not have the time or desire to hold the baby, she was taken to the Soiled Utility Room to die.

After this story went public, Christ Hospital created its "Comfort Room," a small nicely decorated room complete with a First Foto machine if parents wanted professional pictures of their aborted baby, baptismal supplies, gowns, certificates, foot printing equipment and baby bracelets for mementos – and a rocking chair to rock the baby to death (see photos of the Comfort Room on next page).

One night, a nursing coworker was taking a baby with Down syndrome who had survived his abortion to the

Soiled Utility Room, because his parents did not want to hold him, and she did not have time to hold him.

I could not bear the thought of this suffering child dying alone in a Soiled Utility Room, so I rocked him for the 45 minutes he lived. He was between 21-22 weeks old, weighed about ½ pound, and was about 10 inches long. hospital and work at a place that didn't commit abortions. The other was to stay and fight Christ Hospital's abortion practice.

At that point I read a Scripture I thought spoke directly to me, Proverbs 24:11-12:

Rescue those who are unjustly sentenced to death; don't stand back and let them die. Don't try to disclaim responsibility by saying you didn't know about it. For God, who knows all hearts, knows yours, and he knows you knew! And he will reward everyone according to his deeds.

I decided that to quit at that point would be disobedient. Sure, I might be more comfortable if I left the hospital, but babies would continue to die.

I continued to work at the hospital for another two years









He was too weak to move very much, using his energy trying to breathe.

Toward the end of his life, he was so quiet I could not tell if he was alive unless I held him up to the light to see whether his heart was still beating through his thin chest wall.

Once he was pronounced dead, I folded his little arms across his chest, wrapped him in a tiny shroud, and carried him to the hospital morgue, where all our dead patients were taken.

After I held that baby, the weight of what I knew became too much to bear. I had two choices. One was to leave the

after eventually going public. I was finally terminated, but my life had already taken a turn into full-time pro-life activism, which included testifying 14 times to date before federal and state legislative committees.

President George W. Bush signed the Born Alive Infants Protection Act in 2002, which codified into law that abortion survivors are constitutionally protected persons.

A follow-up bill, the Born Alive Abortion Survivors

Protection Act, which would prosecute medical professionals for violating BAIPA, has yet to be signed into law.

LOVE IN ACTION

The Bible employs many names to describe God's attributes.

The first use of "El Roi," which means "The God Who Sees Me," was spoken by an unmarried pregnant mother to whom God showed compassion. Her name was Hagar.

Hagar was slave to Sarah, the Hebrew matriarch, who was unable to conceive. Genesis 16 tells us Sarah commissioned Hagar to bear her a child by her husband and Hebrew patriarch, Abraham.

After Hagar became pregnant, however, her relationship with Sarah soured, and Hagar ran away into the desert.

But God was watching Hagar's dismal plight and reached out to her, advising her to return and

making a spectacular promise to "greatly multiply your offspring so that they will be too numerous to count."

God's care and compassion are what evoked Hagar to proclaim him El Roi.

We read in Genesis 21 that Hagar again found herself in the desert, forced out of the home by Sarah, but now with born son Ishmael.

This time, God heard not Hagar's but Ishmael's cry after the two ran out of water, and He provided a well.

God cares for isolated and abandoned moms and their children, born and unborn. So should we.

There are many ways to support children, including health care, child care, parenting education, foster care, and adoption.




One impact study done in a local child welfare office in Milwaukee County found that children who had one consistent case worker achieved permanency 74.5% of the time.

If they had two case workers, that number dropped to 17.5%.

In cases where children had six or seven case managers, their permanency rate was 0.1%.

As soon as I saw the pregnancy test, I called my husband at work to tell him the great news.
"I'm pregnant again!!" There was silence on the line. "We'll talk about it when I get home."

But when my husband came home, he had had a change of heart. He was excited, thrilled to have another child and immediately took me to an expensive dinner to celebrate, where we agreed to name the child Teagan if a girl and vowed to keep thinking of a name for a boy. I was ecstatic. I couldn't wait to be visibly pregnant again and to give birth again.

That was the first day after we knew. The second, third, and fourth and so on days were the exact opposite. My husband was depressed and angry, constantly low on patience with our 3yo daughter and me. He kept coming up with reasons we shouldn't have the baby: money, needing a bigger home, a larger income and more childcare.

He wore me down.


The day of the procedure I wasn't upset. I had come to terms with the necessity of our decision.

Within a month, my husband had left my daughter and I twice. He never came back the second time. We divorced shortly thereafter.

I realize now that no matter how much I wanted that pregnancy, I didn't want to be a single mother with a toddler and a newborn.

APPENDIX A

Prenatal Development and Types of Abortion





THE VULNERABLE PREBORN

At the federal level, abortion is legal in the United States up until birth. Read on to learn more about prenatal development taking place in the first, second and third trimesters of pregnancy and the most prevalent methods of abortion used during each stage.

The First Trimester

During this stage of pregnancy, the preborn child is developing rapidly. At four to five weeks LMP — that is, four to five weeks since the first day of the mother's last period, and just 21 days following fertilization (conception) — the

baby's organs start to develop, and the heart begins to beat. These developmental milestones often take place before the mother even knows she is pregnant.

8 WEEKS

The preborn baby's hands and feet are developing, and the neural pathways in her brain start to form. The child is constantly moving in the womb, although the mother cannot feel it.

9 WFFKS

The child can suck her thumb, open and close her jaw, stretch, and sigh. The baby's teeth begin to form, and the heart completes dividing into four chambers.

The child's vital organs have developed and started to function. The baby is rapidly moving in the uterus, and tiny nails begin to form on the child's hands and feet.


12 WEEKS

The child develops reflexes, and can open and close fingers, respond to touch, and make movements with her mouth. The child's nerve cells are developing rapidly.

Suction (Aspiration) D&C

A suction, or aspiration, D&C abortion is a procedure in which a suction catheter is inserted into the mother's uterus to extract the preborn baby. Tools are then used to scrape the lining of the uterus to remove any remaining parts.

The Second Trimester

13 WEEKS

The preborn baby's fingerprints are visible, and the child's organs are visible through his or her thin skin.

16 WEEKS

The child's toenails begin to form, and his or her face and limbs are much more developed. The baby's heart is pumping roughly 25 quarts of blood every day and will continue as the child develops in the womb.

20 WEEKS

The child's nervous system is developed enough to feel pain. Research by the University of Toronto shows that babies at this stage can feel pain in the womb — even with greater intensity than adults. Almost all mothers feel the baby move by this point in pregnancy.


24 WEEKS

The baby is roughly a foot long, and his or her brain is developing rapidly. The child's lungs are also developing into their branch-like structure. At this age, almost all babies can survive outside the mother if given proper support.

Induction

A second and third trimester induction abortion is conducted from 16 weeks LMP to term. The abortionist will usually first kill the baby in utero by injecting a substance that causes cardiac arrest and induces the mother's labor to deliver her baby stillborn. If the abortionist does not kill the baby first, s/he may be born alive.

The Third Trimester

At 25 weeks, a preborn child is fully developed and considered viable — that is, with proper medical care and attention, s/he would be able to survive outside of the womb. While medical staff is required to provide lifesaving care to a child who survives an abortion procedure, it is unlikely that doctors and hospitals will take intensive measures to rescue the baby if s/he is born alive following an abortion procedure.

25 WEEKS

A preborn child is fully developed and considered viable, meaning the baby would likely survive outside of the womb if s/he were born. The baby's hair continues to grow, and the color and texture can be discerned. At this stage, the child is around 131/2 inches long, from head to heel.

27 WEEKS

The child's brain tissue continues to develop. and the baby is sleeping and waking in regular cycles. The mother may even feel the child hiccup at this stage, which may become more common as the pregnancy progresses.

31 WEEKS

The baby can turn his or her head to the side and is very active in the womb. The baby kicks and does somersaults, and develops more fat underneath the skin.







"The role of the General Board in this matter is not to direct churches, but to assist them in carrying out ministry and advocacy according to their convictions. Therefore, as a reflection of American Baptist thought, this resolution is offered to assist our churches. As American Baptists, members of a covenant community of believers in Jesus Christ, we acknowledge life as a sacred and gracious gift of God. We affirm that God is the Creator of all life, that human beings are created in the image of God, and Christ is Lord of life. Recognizing this gift of life, we find ourselves struggling with the painful and difficult issue of abortion. Genuine diversity of opinion threatens the unity of our fellowship, but the nature of the covenant demands mutual love and respect. Together, we must seek the mind of Christ. As American Baptists we oppose abortion, as a means of avoiding responsibility for conception, as a primary means of birth control, without regard for the far-reaching consequences of the act. We denounce irresponsible sexual behavior and acts of violence that contribute to the large number of abortions each year. We grieve with all who struggle with the difficult circumstances that lead them to consider abortion. Recognizing that each person is ultimately responsible to God, we encourage men and women in these circumstances to seek spiritual counsel as they prayerfully and conscientiously consider their decision."







You shall not kill the embryo by abortion and shall not cause the newborn to perish.⁷⁵

God, the Lord of life, has entrusted to men the noble mission of safeguarding life, and men must carry it out in a manner worthy of themselves. Life must be protected with the utmost care from the moment of conception; abortion and infanticide are abominable crimes.⁷⁶



% of Catholics who say abortion should be...









"In today's society, abortion has become a common practice, defended by deceptive arguments. If you face questions about this matter, you can be secure in following the revealed will of the Lord. Latter-day prophets have denounced abortion, referring to the Lord's declaration, "Thou shalt not ... kill, nor do anything like unto it" (D&C 59:6). Their counsel on the matter is clear: Members of The Church of Jesus Christ of Latter-day Saints must not submit to, perform, encourage, pay for, or arrange for an abortion. If you encourage an abortion in any way, you may be subject to Church discipline. Church leaders have said that some exceptional circumstances may justify an abortion, such as when pregnancy is the result of incest or rape, when the life or health of the mother is judged by competent medical authority to be in serious jeopardy, or when the fetus is known by competent medical authority to have severe defects that will not allow the baby to survive beyond birth. But even these circumstances do not automatically justify an abortion. Those who face such circumstances should consider abortion only after consulting with their local Church leaders and receiving a confirmation through earnest prayer. When a child is conceived out of wedlock, the best option is for the mother and father of the child to marry and work toward establishing an eternal family relationship. If a successful marriage is unlikely, they should place the child for adoption, preferably through LDS Family Services"







"Only in this case can the pregnancy be terminated after 120 days. The logic behind this is an agreed upon legal maxim in Islamic law: certainty should not be overridden by doubt. In other words, a potential life (that of the infant) should not threaten a stable life (that of the mother).... Between 40 and 120 days from conception, the four madhabs disagreed, even within their own ranks, and so we will state the dominant position of each school. The Mâlikis traditionally were the strictest in this regard; they opposed any medical technique as a means of birth control (such as drinking medicine), with some even opposed to seeking to expel the semen after intercourse. The dominant Hanafi position was far more lenient in permitting abortion up until 120 days from conception, with some even allowing it without the husband's permission. Nowadays, many contemporary juristic assemblies prescribe the position held by the Hanbalis; permitting abortion up until 40 days, and only up until 120 days when a pressing need is present (such as rape, or an extreme fetal deformity incompatible with life)."

"Jewish legal authorities from ancient times through the present day categorize abortion as a form of murder. Throughout most of history, it was impossible to determine whether a baby in the womb would be viable once he or she emerged—that this precluded a court from imposing capital punishment upon the murderer of a fetus hardly means that the act is therefore permitted. Jewish law also not merely permits, but demands, that the Sabbath be violated in order to save a fetal life. As lifesaving activity is the only situation in which a Sabbath violation is permitted; were a fetus not deemed alive by the Torah, this behavior would be entirely prohibited. Thus, the NCJW document's claim that "Jewish law does not consider a fetus to have the status of personhood" is categorically false. But the most fundamental reference to Judaism's unique perspective is perhaps found in the Mishnah. According to Jewish teaching, Moses was given most of our laws orally at Sinai, and these were only written down when later rabbis recognized that its many details were in danger of being forgotten. The Mishnah, then, is the earliest written record of this Oral Law. And it teaches us that termination of pregnancy is not merely permitted, but obligatory, when the fetus endangers the mother's life—'because her life precedes his.' It could not be more clear that a fetal life is indeed a life. Termination of pregnancy is an indescribable tragedy if the life of that fetus cannot be saved, as well; it is never a 'choice.'"






"[What] is the most effective way to bear witness to our belief that we exist because of God's love? This belief is at the root of the Orthodox opposition to abortion and to every other detail of the holiness of every human life. Many of those who oppose abortion have worked against a legal climate that has made the choice of abortion a relatively simple thing. The United States has the most permissive abortion laws in the industrialized Western world; there are more restrictions even in the most secular nations of Western Europe. Working to change the legal climate makes good sense and is one valuable form of pro-life witness. It is not enough, however. Harvard Law professor Mary Ann Glendon has pointed out that the United States not only has the most permissive abortion laws in the industrialized West; its social policy does less for women and children than any other industrialized nation. She sees a connection. A nation in which single women, or poor married women, are afraid to have children because they will be left alone if they do is one in which abortion will often be seen as a lesser evil. To see it that way is wrong, from a Christian point of view. But it is also wrong to condemn abortion, without trying to help those for whom bearing a child will involve real burdens."

Be it further resolved that we voice our opposition to any legislation at provincial, state, or national levels which would bring about a climate designed to undermine the sanctity of human life, further destroying the moral fiber of our society. Be it further resolved that we give ourselves to earnest prayer during the time of [the revival endeavor called Global] Conquest for an awakening in our North American society of moral consciousness concerning this issue. "1. A woman facing a problematic pregnancy or an unexpected pregnancy should expect to receive support, love, acceptance and wise counsel from her pastor(s), counselor(s), physician(s) and fellow Christians. Regardless of the woman's decision, the Church should always provide compassionate biblical and spiritual guidance to that individual. 2. The Church must serve as a loving and supportive community to any man involved to inform and direct him in his personal responsibilities and obligations as the child's father. 3. The Church must be supportive of the woman who chooses life for the child of an unexpected pregnancy and must seek ways to support and care for those children carried to term through unexpected pregnancy. 4. The Church must serve as a loving and supportive community to those who have experienced physical, emotional, or spiritual wounds as a result of undergoing an abortion or placing a child for adoption. 5. Christians should individually and corporately oppose abortion (except under the most extreme of circumstances that endanger the physical life of the mother), and do everything in their power to provide support groups, para-church ministries and sponsoring agencies that offer viable alternatives to abortion. 6. The Church should declare to the world and teach its members that abortion should never be used as a convenience or a means of birth control. 7. The Church should actively oppose the killing of human embryos through the extraction of stem cells for medical research or treatment. 8. The Church should oppose the practice of producing more embryos by in vitro fertilization than would be implanted in utero, which would either be destroyed immediately or stored frozen with the strong practical likelihood of later destruction."



"The fundamental task of the church is the proclamation of God's Word as it bears upon individuals and institutions. The Holy Scripture, which is God's Word written, is graciously given as the power of God unto salvation for those who believe. But it is no less the absolute authority given to regulate any institution or individual as regards the created life which only God has the right to give or take away. On this basis we believe the intentional killing of an unborn child is a violation of God's command and authority. Scripture considers such a child a person and thus covered by Divine protection even as a person after birth. Any medical support or historical precedent can only be of secondary authority when we have a clear Word from God on moral questions. Yet as often is the case, a candid evaluation of secondary authorities supports the teaching of Scripture. All truth is God's truth, and any alleged conflict is thus but a misreading of one area of His truth. We are convinced Scripture forbids abortion. The premise of the personhood of the unborn child and the premise of the universal validity of the Sixth Commandment, if true, necessitates the conclusion that abortion is wrong."






